# VI. Immediate Action Items

## A. TVSA Scholarships – David Guinn

Dan Deese tabled the item due to David Guinn's absence

## B. T-Shirt Sales – Dan Deese

Dan D. recommended that we move forward with the proposal of t-shirt sales through Soccer4Every1. Dan suggested that we reduce the initial purchase of shirts to 120, instead of the 180 originally proposed by Soccer4Every1. Dan S. motioned to release funds of, not to exceed, \$1200 for the customization and purchase of 120 TVSA t-shirts to be sold through Soccer4Every1. Dave H. 2<sup>nd</sup> the motion. Motion carried with Ralph abstaining.

# C. Graphic Designer – Dan Deese

Dan D. recommended that we use a graphic designer to assist with the design of the TVSA t-shirts to be sold at Soccer4Every. He suggested that we put the TVSA logo on the front left pocket and something on the back. Dan D. told the group that Soccer4Every1 has a graphic designer that they work with and it would cost approximately \$250. The group briefly discussed the benefits of using a graphic designer. During the discussion it was suggested that we talk with TVSA Coach Mike Sullivan since he does graphic design. Dan S. motioned to spend, not to exceed, \$250 to hire a graphic designer to assist with the design of the TVSA t-shirts to be sold at Soccer4Every. Cassie 2<sup>nd</sup> the motion. The motion carried.

# E. U12 Practice/Lights – Perry Ludwig

Four teams need to be moved to fields with lights. Holly will handle this. Due to problems with the Practice Scheduler, this has been an issue. Perry stated that the logging in issues with the scheduler must be resolved by the time the new website comes online. Dan S. says the problem has already been fixed by Joe Avila at SageBlu. The group discussed eliminating the age/division restriction for all the fields so that the U12 coaches could self-schedule at a lighted field.

# F. BOD Referee Certification – Derek Rogers

Derek told the group that he would like every BOD member to get certified as Grade 9 referee and asked the group to discuss the topic. Derek said that he feels that this would help BOD members discuss refereeing concerns with coaches and parents after the game and assist them in explaining the difference between the law and application of the law. Some board members were concerned about having to referee games. Derek suggested that you only ref a game if you want to be put on the ref schedule, you do not have to ref. He also said that it would be helpful if a BOD member could step in and referee a game if a ref did not show up. Derek and other BOD members who already hold the certificate encourage the reluctant members to give it a try. Dan D. asked Derek to explain the difference between the Grade 8 and Grade 9 certification. Derek said that the Grade 9 certification is a shorter course and only allows you to referee recreation level games. Overall, the group thought it was a great way to show support for our refs, especially since refs tend to leave because of the treatment they receive by coaches. Derek motioned that all board members are required Grade 9 referee certification will be reimbursed by TVSA. Ralph 2<sup>nd</sup> the motion. The motion carried with Linda abstaining.

## G. BOD Fall Jackets - Derek Rogers

Derek asked the board to discuss getting jackets with the TVSA logo for the board member. Derek stated that our board member shirts get covered up with personal jackets in chilly weather and then we are not always recognized as a board member. This was briefly discussed.
